2013 VOTE BY MAIL ELECTION TO ENHANCE TURNOUT AND CONVENIENCE FOR VOTERS

When pledging allegiance to the flag of our country we acknowledge our form of government when we say, "...and to the Republic for which it stands..." Indeed, the Constitution of the United States guarantees every state a Republican form of government. A Republic is similar to a Democracy in that both depend on the direct involvement of the citizens.

In a Democracy, all sovereign power lies with the people who exercise that power as a group and vote on virtually every decision - majority rules. In a Republic, citizens elect representatives and delegate to them the sovereign powers of the people to govern. As citizens of a Republic, our greatest duty is to participate in the selection of those to whom we delegate the power to govern. Therefore, it is disappointing that many choose not to exercise their right to vote.

Based on statistics for Salt Lake County, voter turnout in Presidential election years is always highest. In 2012, more than 80 percent of registered voters cast a ballot. In 2008,

more than 70 percent of registered voters cast a ballot. However, in mid-term elections, voter turnout drops to approximately 50 percent of registered voters. In odd years when municipal elections are held, voter turnout drops dramatically.

For Cottonwood Heights specifically, 86 percent of registered voters took part in our first municipal elections in 2004. (Of course, that was a presidential election year and municipal elections are not typically held on those years.) In subsequent elections, voter participation dropped to an average of 40 percent in 2007, 20 percent in 2009 and 20 percent in 2011. While not all who are eligible are registered to vote, we do have about 19,500 active registered voters in Cottonwood Heights, which is a pretty high percentage of those eligible.

In an effort to encourage greater participation when voting for elected officials, Cottonwood Heights volunteered to be a test case for voting by mail in this year's elections. In other words, there will be no voting at traditional polling

places in Cottonwood Heights for either the primary election on Aug. 13 or the general election on Nov. 5.

The motivation for this experiment is the rising popularity of voting by mail in our city. In the 2012 presidential election, more than 6,000 voters requested mail ballots. More than 5,000 voters, or 84 percent of those who requested voting by mail, returned their ballots. Six thousand voters represents nearly one third of all registered voters in the city. The percentages grow even greater when applied to the low voter turnout in off-year municipal elections.

In addition to voting by mail, early voting has become more and more popular. It is estimated that between early voting and voting by mail, there are just as many votes cast as those made in person at polling locations on Election Day.

There are many distinct advantages to voting by mail and very few disadvantages. Voting by mail enables all citizens to carefully study the issues and vote in an informed way in the comfort of their home

Cottonwood Heights 2013 Municipal Election

This year, three municipal government seats are up for election, and all have four-year terms: Mayor, District Three Councilmember and District Four Councilmember.

Citizens desiring to run for office must file a Declaration of Candidacy **in person with the Cottonwood Heights City Recorder** at the city offices, located at 1265 East Fort Union Blvd., Suite 250. The forms will be available in the office of the city recorder beginning Monday, June 3.

The filing period will run: **Monday, June 3 through Friday, June 7** during regular office hours, which are 8 a.m. to 6 p.m. Monday through Thursday, and 8 a.m. to 5 p.m. on Friday. There is a \$25 filing fee. Candidates must have been a resident of Cottonwood Heights for at least 12 months (365 days) immediately prior to the date of the general election on Nov. 5 and must be

a current registered voter in Cottonwood Heights. Candidates running for a city council district must be a resident of that district.

A candidate orientation meeting is scheduled for Thursday, June 15 at 5 p.m. at the city offices. Please direct questions to Linda Dunlavy at 801-944-7021.

SPRING FIRE SAFETY

As spring approaches, thoughts turn to cleaning up from the long winter and making repairs around the home while enjoying the outdoors. Keeping a few safety thoughts in mind will help you make your experience much more enjoyable.

Inside the Home:


- Check and clean your smoke and carbon monoxide detectors.
- Check your fire extinguishers.
- Check for overloaded or damaged extension cords.
- Prepare for storm related outages (make sure your flashlights and portable radios have batteries and that other supplies, such as bottled water, are stocked and available).
- Practice exit drills with your family so everyone knows what to do in case of an emergency.
- Properly store household chemicals and never mix cleaning agents.

Outside and Around the Yard:

- Make sure your house address numbers are up and visible from the street
- Clean up yard debris. Cut back dead limbs and grasses.
- Maintain a clear “fire zone” of ten feet around structures. Clean up leaves and debris and consider using stone or non-combustible mulches.
- Check outdoor electrical outlets and other electrical appliances.
- Get your grill cleaned and serviced. Check all propane tanks and lines for leaks and damage.
- Keep 100 feet of garden hose with an attached nozzle connected and ready for use.

In the Garage or Shed:

- Clean up and properly store paints and pool and yard chemicals.
- Check fuel containers for leaks and make sure they are properly stored.
- Have all power equipment cleaned, serviced and readied for use.

City Shakes Things Up During The 2013 ShakeOut!

Did you feel the big earthquake that hit Utah in April? We didn't either—probably because it didn't happen—but we definitely practiced for it!

On April 17 through April 20, nearly one million people around Utah participated in the 2013 Great Utah ShakeOut. Government agencies, businesses, schools, religious organizations, families and friends all took the opportunity to prepare themselves a little more for a possible large-scale earthquake, and Cottonwood Heights was no different.

Last year, the city participated in ShakeOut by setting up a mock Emergency Operations Center and running an hours-long drill with the city council and staff as well as our county and



state partners. This year, the city teamed up with the Utah Red Cross to open an emergency shelter simulation at the Cottonwood Heights Recreation Center on April 18.

The day-long exercise served a variety of functions. It allowed local residents to become trained on how to set up and staff a Red Cross shelter. It provided a way for the city to test its mobile command unit as well as the amateur radio network on which we depend for emergency communications. It gave nearly 170 students and community members to see what the inside of a disaster shelter looks and feels

like. And it gave volunteers such as Southern Baptist Disaster Relief a chance to practice their skills and help the emergency preparedness effort by serving warm meals to shelter staff.

It also helped city leaders test our emergency plan and find ways in which to improve. The lessons learned in drills like the ShakeOut will help the city to respond effectively should we ever face an emergency situation in Cottonwood Heights.

We are grateful for the community partners that made this event possible: Utah Red Cross, Cottonwood Heights Amateur Radio, Southern Baptist Disaster Relief and, of course, the community volunteers. Thank you for your help!

Road Work Ahead

As the weather warms up, the city has many construction projects planned to help improve our community. A lot of routine maintenance on our roadways will be performed this summer. We wish our roads would last forever, but since they don't we strive to find the most cost-effective means to maintain our road in the best condition. We are proud to announce that we will be treating more than 1.7 million square feet of roadway this year! Some of the planned projects include:

Union Park Avenue

Cottonwood Heights and Midvale will be teaming to make improvements to Union Park Avenue. Work will include new landscaped medians, street lighting, drainage improvements and road surface treatments. The project is currently being advertised for construction bids. Once a contractor is selected, a schedule for construction will be established and work will likely start in June. Message boards will be posted seven days prior to the start of work to notify users of the upcoming construction.

Neighborhoods East of Wasatch Boulevard

Residents on the east side of the city above Wasatch Boulevard can expect street maintenance work later this summer and into next spring. Kings Hill Drive is scheduled for an overlay. Top of the World Drive and Prospector Drive will receive chip seals while other roads in the area will receive slurry seal treatments.

New Sidewalk on 7200 South

Improvements are not limited to streets this year. We will also be installing new sidewalks along 7200 South from about 1400 East to 1750 East starting in mid-May. We are able to complete this project thanks to a grant from the "Safe Routes to Schools" program. The work is being managed through UDOT.

Big Cottonwood Canyon Trail

The section of Big Cottonwood Canyon Trail that connects the park and ride in the mouth of the Canyon to the rest of the trail in the area will be completed this spring.

Trip Hazard Mitigation

We will be out cutting "trip hazards" on city sidewalks again this year. Last year, 1,727 trip hazards were removed by this process. Cutting away trip hazards as opposed to replacing the sidewalks saved the city and its residents of over \$400,000 in fiscal year 2012.

Every road in our city requires ongoing maintenance. Cars, rain, snow, salt, ice, sunshine and the soil underneath the road all combine to take a toll on our roadway surface. Over time, the roadway begins to weaken and deteriorate, requiring routine maintenance. This maintenance work may cause us to alter our normal routes to work, school or other activities for a time. With that in mind, we want to give drivers as much notice as possible before construction begins in order to adjust routes and schedules or find alternative routes. More detailed flyers will be distributed to affected neighborhoods before work starts. We appreciate your patience as we work to improve the Cottonwood Heights community.



Russo honored as Chief of the Year

During the Utah Chiefs of Police Association Educational Conference on March 27, Cottonwood Heights Police Chief Robby Russo was honored as the group's Chief of the Year among medium-sized police departments within the state of Utah.

"With the recent statewide recognition at the Zero Fatalities Summit for their excellence in improving traffic safety, it is no surprise to see Chief Russo honored for his skills in leading CHPD," said Mayor Kelvyn Cullimore, Jr. "In our opinion, he has always been a top flight police chief. We are pleased that fact is being recognized by his peers."

Russo was acknowledged for his commitment



to curtailing the illegal use of alcohol as well as illicit and prescription drugs in Cottonwood Heights. Under Russo's command, CHPD has removed hundreds of impaired drivers from city streets each year since 2008, making the city a safer place to live, drive and work.

at a time convenient to them. It allows voters to discuss issues and become educated. I compare it to taking an open book test at school.

Approximately 30 days before the election, ballots will be mailed to each registered voter that has voted at least once in the last four years. Those who have been “inactive” voters for the last four years will receive a postcard inviting them to request a ballot.

Voting by mail eliminates the costs of staffing early voting and Election Day voting locations. This cost savings is partially offset by the cost of mailing ballots. However, we believe the outcome will be not only lower costs, but improved voter participation.

Some have expressed concern about voter fraud being more prevalent in a vote by mail process. Each ballot envelope contains an affidavit that must be signed by the voter. The signature on the envelope affidavit is compared to the signature on that voter’s registration form. If the signatures do not match, the voter is notified. If you are

like some that use an informal and a formal signature, be sure your signature on your ballot is consistent with the signature on your original voter registration form. If you forget to sign the affidavit on your ballot envelope, you will be contacted and provided the opportunity to sign the affidavit. Every effort has been made to diminish the risk of voter fraud.

Ballots can be completed and mailed back to the Salt Lake County Clerk in the postage paid envelope provided, or there will be ballot drop boxes at the Salt Lake County Government Center and the Cottonwood Heights City Office. Ballots will be mailed out weekly leading up to the election to accommodate those who newly register or have changed addresses. Ballots will even be mailed daily the week before the election in an effort to service all voters desiring to participate. For those voters who need assistance or who did not receive a ballot, they may vote at a vote center located at Cottonwood Heights City Hall on Election Day.

State law requires that ballots returned by mail

be postmarked by the day before Election Day. Ballots received in the County Clerk’s Office by Election Day will be counted and the results will posted at 8 p.m. on Election Night. While this may eliminate the fun and anticipation of watching poll results roll in throughout the evening, it will also shorten the campaigning process as most candidates realize votes will be cast before Election Day. Eligible ballots received after Election Day will be counted and included in the “official results” presented to the Board of Canvassers Meeting.

We are truly excited about being a test case for voting by mail. We believe the positive aspects far outweigh the negative, and we are confident it will result in a significant improvement over the 20 percent average voter turnout we have seen in the last two municipal election cycles. In the coming months, we will be posting more information about voting by mail online and in this newsletter. We encourage your participation and welcome your feedback about the experience.

NEIGHBORHOOD WATCH IS SIMPLE

Once A Skeptic, Now A Neighborhood Watch Coordinator

Last year my feelings about Cottonwood Heights changed dramatically.

I had been asked several times to get involved with Neighborhood Watch. My wife and I were relatively new in a very established neighborhood, and we didn’t feel like we knew very many people. I have a very busy life and didn’t feel the desire or the need to participate. I really didn’t know what Neighborhood Watch was other than my limited perspective regarding its seemingly worthy goals.

Fortunately, I was invited by a neighbor to attend a planning meeting to become more aware of the efforts that were taking place in our neighborhood. During the short meeting I became fascinated with the incredible amount of concern, planning and effort that members of our neighborhood were expending to help me and most of the other neighbors like me that had no idea what was occurring. I felt an immediate desire to help in some small way.

Little did I know that 5 minutes later the person conducting the meeting would ask if anyone was willing to take on an additional responsibility by serving as Neighborhood Watch Coordinator. In my mind I knew I could do it, but I was scared to say anything because I had not been involved before and I was totally unfamiliar with how the group worked. I became obvious that no one was going to offer to accept the responsibility, so I mustered the courage to open my mouth. To my surprise everyone seemed genuinely happy that I would do it.

One of the most rewarding aspects of

this responsibility has been organizing and participating in the annual neighborhood party. Last year, nearly 300 people attended the party! We applied for a permit to close off a cul-de-sac and had neighbors cook hotdogs and hamburgers, the most amazing chili you ever tasted and salads and desserts of every variety. Each family that came was asked to make a small donation (if they were able). The funds were used to offset some of the costs of the party and to provide emergency supplies to stock the Community Emergency Response Team (CERT) trailer.

To my surprise, the response to the party was fantastic. Everyone had a great time. Many of the new families that had moved into the neighborhood felt it was a great way to get to know others. The old timers were equally happy to get to know the new families. Many new friendships and acquaintances were forged that day.

I was amazed at how much the party helped the purposes of Neighborhood Watch by creating a mechanism for everyone to become better acquainted with each other and thus more comfortable watching out for something suspicious that may be occurring on their neighbor’s property.

I must admit that the experience of working with Neighborhood Watch and getting to know our city staff has made me realize what a flat-out awesome city we live in. I am amazed just how much everyone at the city offices is willing to help. I absolutely love Cottonwood Heights and feel very proud and lucky to live here. “A Spring Day in Cottonwood Heights” Photo Exhibit



Historical Answer

Answer To May Historical Committee Question:

Greenfield Village plat A was approved by Salt Lake County on Feb. 26, 1953 and Cottonwood Ridge (Virginia Hills Drive) was approved on Dec. 2, 1953.

Greenfield Village is the neighborhood near the northwest corner of Highland Drive and Fort Union Boulevard. It sits between Highland Drive and approximately 1700 East, and Ft. Union Boulevard to the south and the I-215 freeway to the north. The number of homes in this subdivision almost doubled the number in Butlerville at the time.


Cottonwood Ridge, better known as Virginia Hills, is located on top of Butler Hill at approximately 2700 East and Fort Union Boulevard. It is on the north side of Ft. Union Boulevard, immediately east of the church on the top of Butler Hill. Virginia Hills Drive runs north from Ft. Union Boulevard towards the edge of the hill.

At the time these subdivisions were built, Fort Union Boulevard was known as "70th South" even though only a small portion of it was actually on 7000 South. In the very late 1800s and early 1900s, the road between 13th East and Butler Hill was called the Butlerville Road and from Butler Hill running east to the mouth of the canyon it was called the Butler Bench Road.

As such, he works to preserve the quality of our city's creeks and streams by making sure they remain free of excess silt, debris, and pollutants.

In addition to these responsibilities, Kyle manages the city's concrete replacement

program. This program assists the city's residents with replacing damaged and hazardous sections of sidewalk, approach, or gutter in front of their homes. It also helps bring the city's walkways into compliance with the Americans with Disabilities Act.

Kyle bleeds red when it comes to collegiate sports and has received two degrees from the University of Utah, most recently a Master of Public Administration. He enjoys the Utah outdoors and tries to spend his winters on the ski hill and his summers on the lake. "I enjoy a good book as much as I enjoy a good joke," said Kyle. "I speak French and love French cuisine... especially the pastries! I like spending time with people and have worked for eleven years as a part-time respite care provider for children with autism.
