RESOLUTION No. 2019-77

A RESOLUTION EXPRESSING APPRECIATION TO AND HONORING MICHAEL L. SHELTON

WHEREAS, at their regularly scheduled meeting on 17 December 2019, the members of the city council (the “*Council*”) of the city of Cottonwood Heights (the “*City*”) took the opportunity to reflect on the eight years of public service by councilmember Michael L. Shelton, whose term of office will end on 6 January 2020 following his decision to not run for re-election; and

WHEREAS, further, Mike’s innate desire to do the right and honorable thing in all situations, and his willingness to carefully explain his thoughts and concerns regarding proposed actions by the City during Council discussions, has provided a stellar example to the City’s elected and appointed officers, staff and residents of personal integrity and the good that can be achieved through diligence, wisdom, and collaborative teamwork; and

WHEREAS, consequently, the Council desires to express appreciation to, and to honor Mike for, his diligent and selfless work on behalf of the City and its residents;

NOW, THEREFORE, BE IT RESOLVED by the Cottonwood Heights city council that the heartfelt appreciation of the City is hereby given to Michael L. Shelton for his efforts on behalf of the City as a city councilmember for the past eight years, with due acknowledgement of the support freely given by Mike’s wife Marshelle and their children to make such efforts possible.

This Resolution, assigned no. 2019-77, shall take effect immediately upon passage.


