RESOLUTION No. 2020-09

A RESOLUTION APPROVING AND RATIFYING DECLARATION 2020-01 DECLARING A STATE OF LOCAL EMERGENCY CONCERNING THE COVID-19 PANDEMIC

WHEREAS, on 16 March 2020 the city manager of the city of Cottonwood Heights (the "City"), in his capacity as the City's chief executive officer, issued Declaration 2020-01 (the "Declaration") declaring a state of local emergency in the City concerning the COVID-19 pandemic (the "Pandemic"), as authorized by the Disaster Response and Recovery Act, UTAH CODE ANN. 53-2a-201 *et seq.* (the "Act"); and

WHEREAS, UTAH CODE ANN. 53-2a-208(1)(b), a portion of the Act, provides that a local emergency shall not be continued or renewed for over 30 days without consent of the governing body of the jurisdiction subject to the declaration; and

WHEREAS, because (a) the Declaration will expire on 15 April 2020 absent action of the City's governing body (the "Council") to extend it, and (b) the Pandemic still is occurring, the Council met in regular session on 7 April 2020 to consider, among other things, approving and ratifying the Declaration and extending its duration until such time as effect of the Declaration is terminated by subsequent resolution of the Council; and

WHEREAS, after due consideration, the Council has determined that acting to so approve, ratify and extend the duration of the Declaration is in the best interest of the health, safety and welfare of the City's residents;

NOW, THEREFORE, BE IT RESOLVED by the city council of Cottonwood Heights that the Council hereby approves and ratifies the Declaration and extends its duration until such time as the effect of the Declaration is terminated by subsequent resolution of the Council; and be it

FURTHER RESOLVED by the city council of Cottonwood Heights that all actions heretofore or hereafter reasonably taken by any of the City's officers or employees in connection with the Declaration are hereby ratified and approved.

This Resolution, assigned no. 2020-09, shall take effect immediately upon passage.


