RESOLUTION No. 2020-26

A RESOLUTION APPROVING AND RATIFYING A BID AND AWARDING
A CONSTRUCTION CONTRACT TO ASPHALT PRESERVATION LLP
(CITY WIDE SLURRY SEAL PROJECT)

WHEREAS, the city council (the “*Council*”) of the city of Cottonwood Heights (the “*City*”) met on 2 June 2020 to consider, among other things, (a) approving and ratifying the City’s acceptance of a \$496,209.00 bid from Asphalt Preservation LLP (“*Contractor*”) for construction work involving slurry sealing some or all of the City’s public roads under the City’s project no. 004.20 (the “*Project*”); and (b) authorizing the City’s entry into an agreement for such construction services (the “*Agreement*”) with Contractor on such terms and conditions as may be approved by the City’s mayor and manager in consultation with the City’s director of public works, the City engineer and the City attorney, a draft copy of which is annexed as an exhibit hereto; and

WHEREAS, after careful consideration, the Council has determined that it is in the best interests of the health, safety and welfare of the citizens of the City to approve and ratify the City’s acceptance of Contractor’s bid for the Project and to authorize the City’s entry into the Agreement with Contractor as proposed;

NOW, THEREFORE, BE IT RESOLVED by the city council of Cottonwood Heights that the Council hereby (a) approves and ratifies the City’s acceptance of Contractor’s bid for the Project, and (b) authorizes the City’s entry into the Agreement with Contractor on such terms and conditions as may be approved by the City’s mayor and manager in consultation with the City’s director of public works, the City engineer and the City attorney.

This Resolution, assigned no. 2020-26, shall take effect immediately upon passage.


