RESOLUTION No. 2020-29

A RESOLUTION CONSENTING TO REAPPOINTMENTS TO THE PLANNING COMMISSION

WHEREAS, the city council (the “*Council*”) of the city of Cottonwood Heights (the “*City*”) met on 16 June 2020 to consider, among other things, proposed reappointments to the City’s planning commission (the “*Commission*”) to fill current vacancies; and

WHEREAS, section 19.05.070 of the COTTONWOOD HEIGHTS CODE OF ORDINANCES (the “*Code*”) provides that any vacancy occurring on the Commission by reason of expiration of term of office or otherwise shall be filled by the City’s manager (the “*Manager*”) with the advice and consent of the Council; and

WHEREAS, the Manager desires to reappoint **Dan Mills** and **Jesse Allen**, both of District 3, to continue to serve as regular “at large” members of the Commission, with such appointments to be effective through 30 June 2023 or until their successor are approved; and

WHEREAS, the Council has given advice for the above-described appointments to the Commission for the terms proposed by the Manager; and

WHEREAS, after careful consideration, the Council has determined that it is in the best interests of the health, safety and welfare of the citizens of the City to consent to the reappointment of **Dan Mills** and **Jesse Allen**, both of District 3, to continue to serve as regular “at large” members of the Commission, with such appointments to commence on 1 July 2020 and to end on 30 June 2023 or until their successors are approved;


