RESOLUTION No. 2020-32

A RESOLUTION APPROVING A DISTRIBUTION AGREEMENT WITH SALT LAKE COUNTY FOR C.A.R.E.S. ACT FUNDING

WHEREAS, Salt Lake County (the “*County*”) has received federal funds (the “*Funds*”) under section 601(a) of the Social Security Act as added by section 5001 of the Coronavirus Aid, Relief, and Economic Security Act (Public Law 116-136) (the “*Cares Act*”) to combat and address the effects of the novel Coronavirus disease 2019 (“*COVID-19*”) within Salt Lake County; and

WHEREAS, the County is making expenditures of the Funds to assist citizens and businesses in the County in the containment of COVID-19 and to ameliorate the economic impact of the pandemic and related public health orders; and

WHEREAS, the County has determined that municipalities within the County can play an important role in helping the County to achieve those objectives; and

WHEREAS, the County therefore desires to distribute \$1,007,868.56 of the Funds to the city of Cottonwood Heights (the “*City*”) and has provided to the City, for approval by its city council (the “*Council*”) and execution and delivery by its mayor, a funding agreement in the form that is attached hereto (the “*Agreement*”); and

WHEREAS, for that purpose, the County and the City desire to enter into the Agreement for the purpose of effecting the distribution of Funds on the terms and conditions, and for the purposes, specified in the Agreement; and

WHEREAS, the Council met in regular session on 7 July 2020 to consider, among other things, approving the City’s entry into the Agreement; and

WHEREAS, the Council has reviewed the form of the Agreement and, after careful consideration, has determined that it is in the best interests of the health, safety and welfare of the citizens of the City to approve the City’s entry into the Agreement as proposed;


NOW, THEREFORE, BE IT RESOLVED by the city council of Cottonwood Heights that the Agreement is hereby approved, and that the City’s mayor and recorder are authorized and directed to execute and deliver the Agreement on behalf of the City.

This Resolution, assigned no. 2020-32, shall take effect immediately upon passage.


